It has recently come to our attention that the Internal Revenue Service has decided to no longer accept the 8109 coupons that are currently used **as of December 31, 2010**. All clients will be required to make their payments electronically, whether withholding or corporate estimated tax.

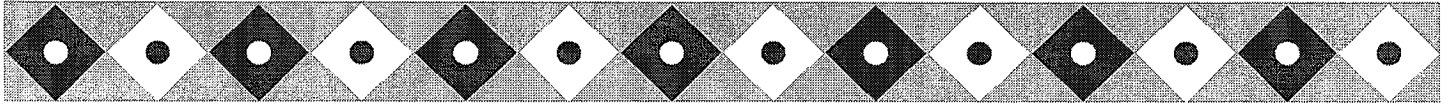
Some clients have already received a notice from the I.R.S. along with a PIN number. If you are NOT currently enrolled please do so as soon as possible. Instructions on enrolling are included in the notice. I would recommend requesting a temporary internet password and going online to make your payments. Any online payments can be viewed or printed for further reference.

For those clients who have not received a notice from the I.R.S., we have enclosed instructions for setting up these accounts online. The attached notice also includes instructions for setting up Maryland withholding payments electronically (Maryland sales tax can also be paid electronically with this account).

Be sure to save the enrollment trace number/activation number from the I.R.S. or the answers to the account questions from Maryland as you may need these in the future.

Federal Payments

Go to www.eftps.gov

Click on enrollment. You will need the following information: Company name, FEIN number, bank routing and account number. Follow step by step instructions.

- 1. Start:** Read the *PRIVACY ACT AND PAPERWORK REDUCTION NOTICE* and click on "I accept" then click on *Enroll me as a: BUSINESS*
- 2. Enroll:** Fill in *Business, Contact and Financial Information* (keep the *Authorize a transaction yourself* box checked).
- 3. Review:** Review and authorize

Save a copy of the confirmation page. You will need the enrollment number for any future changes to the account. You should receive a PIN number and Instruction booklet in the mail within 7 days. This will instruct you on how to obtain a internet password to use EFTPS.gov.

Maryland Payments

Go to www.marylandtaxes.com

Scroll down, on left side click on bfile—business tax.

Choose Create New User Registration Return and follow the prompts.

For this you will need the following information: Company name, FEIN number, CR number with Maryland and your bank routing and account number. Your payments will be made during this process—there is no wait.

A suggested payroll worksheet is attached for your convenience. Change the information to fit your company requirements. This will give you all the information at your fingertips when you need to make a payment
